#### WHEN AN ACT BECOMES LAW

- (1) Specific effective dates a few acts have a specified effective date in the law, if so, these are effective on that date.
- (2) Emergency clauses many acts have emergency clauses which make the act effective on the date it is signed by the governor or becomes law without signature.
- (3) Appropriation acts these acts are effective July 1, 2015 or the first day of the fiscal year. The fiscal year for the state of Arkansas is July 1 June 30.
- (4) General acts acts which contain none of the above are effective 90 days after the general assembly adjourns. The general assembly adjourned sine die on April 22; therefore, the effective date of the acts, without emergency clause or built-in effective date, passed by the 90<sup>th</sup> general assembly will be July 21, 2015. (Editor's note: This index went to press before the official AG's opinion on sine die for the 90<sup>th</sup> General Assembly was released. AAC will send this information out when available.)

#### PROPOSED CONSTITUTIONAL AMENDMENTS

- HJR 1027 Proposing an amendment to the Arkansas Constitution concerning the terms, election, and eligibility of elected officials; defines "infamous crime;" and does not require an election for certain offices where only one candidate is eligible.
- SJR 3 An amendment to the Arkansas Constitution to allow the governor to retain his or her powers and duties when absent from the state.
- SJR 16 An amendment to the Arkansas Constitution to encourage job creation, job expansion, and economic development.
